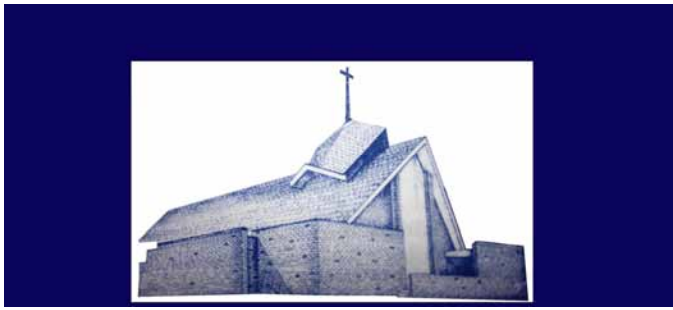

## MASSES INSIDE THE CHURCH



Starting Saturday/Sunday, June 13/14, we will be able to celebrate Mass **INSIDE OUR CHURCH**, and as of the creation of this week's bulletin (Wed), we are only allowed 25% or 50 people, whichever is smaller. We will still be using our **modified** Summer Schedule which is as follows: Sat. @ 5pm, Sun. @ 7:30am & 9am in English and @ 10:30am in Polish. The church will be marked as to where you can sit (keeping social distancing) and masks must be worn. We suggest you also bring your own hand sanitizers. We will only take up one collection, so please put your second collection envelopes/donations in the first collection. Offertory gifts (host & water & wine) will not be brought up to the altar. We will not need the serves of our Altar Servers. As you approach the Altar for communion, the floor will be marked helping us stay 6 feet apart. Please lower your mask and consume the host and raise your mask back in place. When you get back to your pew please sanitize your hands. We ask that everyone receive the Body of Christ in the hand, however, if you feel you need to receive on the tongue please go to Fr. Greg only.
